CASGED COMMUNITY MEETING Minutes - October 8, 2024

Guests

- Councilman Wilson's Office Jordyn Gilliard provided updates on Michael Flynn Field, proposed PWSA work on Chestnut Street and questions regarding the City's operating budget.
- Zone 1 Police Report Ofcs. Defeo and Peyton attended (Officer Peyton in person and Ofcr. Defeo via Zoom). Crime statistics for August for the area were as follows: 7 reports, 2 arrests, 1 traffic stop, 1 search warrant, 1 firearm arrest, no homicides, 1 assault, and no reported burglaries. In response to an audience question, Ofcr. Peyton noted that the City had no specific gang squad. It was noted that there was a reduction in complaints about traffic in East Deutschtown after traffic calming measures (speed bumps) were introduced. It was noted that drug activity near the 279 overpass had brought 41 calls/reports during the period.
- Lindsay Powell's Office Kellie Staraniec was in attendance but had no specific update
- Pittsburgh Parks Conservancy Erin Tobin noted the upcoming Riverview Park Day on Oct 6. She said Spring Hill Park construction was about to start with planned trail connections between neighborhoods

Executive Committee Report

- Proposed Bylaw updates were provided and read (at meeting end) for Community review; highlighted changes included a possible reduction in number of board seats, and a potential reduction in Community and Board meeting frequency.

o Guests – Hullett Properties – Brett Walsh and Brianna Tyson of Hullett Properties offered a presentation on their proposal to turn the current Comfort Inn at 820 E. Ohio St. into a residential facility containing 96 units of voucher-based housing. There were numerous questions amd comments from community members in

attendance physically and virtually, many such questions focusing on the plans Hullett had in place to provide so-called wrap-around services to the proposed residents of the facility, and querying Hullett's experience with providing such services. There were also comments acknowledging the need for affordable housing in the city and in the county, but expressing concern that this type of facility in this location, where there is already substantial drug use and homelessness, would aggravate rather than alleviating certain issues in the neighborhood. It was noted that 96 units at this location represented considerable density and did not seem to be in keeping with current best practice at either the federal or the city level in terms of having affordable housing distributed throughout a diverse community rather than concentrated in a single location.

- o 915 Chestnut demolition to begin shortly, potential to expand the Tripoli Park into that space depending on what the Community wants and work with Rising Tide Partners, owner of the existing structure
