- **b. October Development Conservatorship-** October first pitched the idea of a large Conservatorship filing to CASGED late 2020. CASGED was not in support of such aggressive action

and communicated a preference for community-involved development. While the board does not oppose all conservatorship action, but doesn't believe this Petition is in keeping with the spirit of the law. An attorney has been retained by CA-SGED to oppose inclusion of CA-SGED owned properties. CA-SGED does not have any insight into October Development's long term plans, but is working on securing pro bono representation for individuals who are impacted by the filing. The Northside Leadership Conference reached out to CA-SGED indicating that they did not have any advance information on the filing. Community member C. Rosselot offered to connect CA-SGED to potential resources.
